

Stafford said will officially step down at the end of June, passing over the rein to Baldassario.

"I'll be 69 in July," Stafford said. "It's time, and it's time for me to write, or to consult, or to shape the non-profit world the best I can."

MACC provides support to those in need, primarily East of the River in Manchester, Bolton, Glastonbury, South Windsor, and Willington. Services include free community lunches, a food pantry, showers and clothes washing, and help during emergencies.

Stafford said no matter what, MACC will always focus on its core services to help people thrive, as the founders of MACC set out to do 50 years ago.

"I think the best part of our work is making sure families are around to enjoy each other and making sure kids eat well so they can be a part of their society," Stafford said.

Did You Know?

Article #2 on Fraud and Spam by Stephen By Pedneault, Forensic Accounting

By now most email users should know that when you encounter an email in your inbox that looks suspicious, appears to be spam, or is not expected, it should be deleted without opening it or clicking on any contained links or attachments. That is great advice. However, you may want to review them before simply deleting them. I opened my work email after an evening meeting only to find I my inbox had been flooded with sixty or more spam-like emails within a two-minute span. Nearly all of them were from government agencies. I scrolled through them and found a few sent by AT&T, my firm's wireless provider.

The AT&T emails provided confirmation of upgrades to two iPhone 14s at a cost of nearly \$2,500. Something about the AT&T emails alerted me that they may be genuine, so I called AT&T. My sixth sense was correct – our account had been hacked, and two new devices were purchased through our account to be delivered in a day or so to a Vernon business.

Several calls to AT&T that night and a call to the police resulted in the order being flagged as fraudulent and a criminal case being initiated. We obtained the FedEx tracking information, provided it to the police, the phones were delivered two days later to the Vernon address, and the police intercepted the phones. We were not charged, and our AT&T account was restored.

Had I simply highlighted and deleted the list of spam emails, I would not have been able to stop the fraudulent purchase, and then I would have had to battle AT&T to recover my funds.

The fraudster accessed multiple government websites and, using my email address, signed me up for news, updates, and notices. I figured the idea was to conceal the AT&T emails within a long list of spam emails, hoping the AT&T emails would go undetected. After some effort, I managed to unsubscribe from all of the government sites. I changed and strengthened my passwords, and I continue to monitor my spam mails for the next issue. I highly recommend you consider doing the same.
